Excellency,

The high-level political forum on sustainable development (HLPF) will be held from 10 to 19 July 2017 under the auspices of the Economic and Social Council. Its three-day ministerial segment will be held from 17 to 19 July within the high-level segment of the Council.

In this regard, I would like to take this opportunity to invite your Government to participate in the HLPF at the highest possible level. I would also like to encourage your Government, in line with paragraph 12 of General Assembly [resolution 67/290](#) on the format and organizational aspects of the HLPF, to ensure that your participation in the meetings reflects the balanced integration of the social, economic and environmental dimensions of sustainable development from your national perspectives.

Following the adoption of the 2030 Agenda, the HLPF was designated a central role in overseeing a network of follow-up and review processes at the global level, working coherently with the General Assembly, the Economic and Social Council and other relevant organs and forums, in accordance with existing mandates. The outcome of the HLPF will be a negotiated ministerial declaration.

As set out in General Assembly [resolution 70/299](#), the theme of the 2017 HLPF shall be “*Eradicating poverty and promoting prosperity in a changing world*” and it shall discuss Goals 1, 2, 3, 5, 9, and 14 and their interlinkages, including, if appropriate, with other Goals, with a view to facilitating an in-depth review of progress made on all [Goals](#) over the course of a four-year cycle. Means of implementation, including with respect to Goal 17, will be reviewed annually. Forty-four countries have volunteered to present their national reviews on the implementation of SDGs during the ministerial segment this year. 
