This document, prepared by the NGO Working Group on Women, Peace and Security and Women's International League for Peace and Freedom, is a compilation of specific commitments made during the October 2015 Open Debate on Women Peace Security (WPS) and the High Level Review of UNSCR 1325 (13-14 October 2015). The commitments listed below do not include additional ones that may have been made at the separate launch of the Global Study on the implementation of United Nations Security Council resolution 1325. The table below also indicates whether Member States endorsed UNSCR 2242 that was adopted at the outset of the Open Debate.
