Background Note

Introduction

October 2010 marks the tenth anniversary of the adoption of Security Council Resolution 1325 (2000) on women, peace and security. In this resolution, the Security Council recognized that women’s participation and the inclusion of gender equality concerns in all stages of prevention and resolution of conflict are integral to the maintenance of international peace and security. Since then, the Security Council has complemented its work in this area with three additional resolutions: 1820 (2008) and 1888 (2009) on prevention and response to sexual violence in conflict, and 1889 (2009) on women’s participation in peacebuilding.

Progress towards achieving the goals outlined by resolution 1325 and the subsequent resolutions has been varied and slow. After 10 years, it is critical that the international community accelerates its action and adopts a strategic and systematic approach for the full and effective implementation of resolution 1325.

The Security Council is marking the 10th anniversary of resolution 1325 in a Ministerial-level Open Debate on 29 October 2010, and has expressed its intention to take action on a comprehensive set of indicators on this occasion to track implementation of resolution 1325 (S/PRST/2010/8).

“A 1325 Call to Action” Ministerial-level Side Event

In preparation for the upcoming 10th anniversary of resolution 1325, this event – open to all UN members – aims to provide an opportunity for Member States, UN agencies and civil society partners to move beyond reaffirming our common commitment to demonstrating concrete actions to achieve the women, peace and security agenda.

“A 1325 Call to Action” will introduce the idea of commitments for action and invite you to showcase initiatives – at national, regional and international levels – for strong, time-bound and measurable means to advance the women, peace and security agenda. Member States, UN Agencies and civil society partners are encouraged to highlight initiatives, including joint initiatives, which address some of the key challenges and gaps in our implementation of resolution 1325 and its related resolutions.

Modalities

The event will be co-hosted by the Secretary General of the United Nations, Ministers of Austria, Canada (as Chair of the Group of Friends of Women, Peace and Security), Bangladesh, Chile, Liberia, Namibia, Sierra Leone and the United Kingdom, and the UN Civil Society Advisory Group on Women, Peace and Security, represented by its Co-chair Mary Robinson, who will also act as the moderator of this event.

Participants are invited to deliver short **interventions (2-3 minutes in length)** highlighting examples of **concrete actions and commitments** to implement one or more of the elements of resolution 1325.

Outcomes

A summary of the discussion highlighting commitments for action to implement resolution 1325 will be distributed to all Member States after the event. It will be shared with Security Council members in anticipation of the October open debate.

Moreover, a database will be introduced at the event, which will serve as a catalogue of time-bound, measurable and concrete action submitted by Member States, UN agencies and civil society partners.

ANNEX

Examples of Commitments for Implementing Security Council Resolution 1325

Participants are asked to focus their 2-3 minute interventions on concrete, time-bound, and measurable commitments on women, peace and security. We encourage participants to make joint-commitments where possible.

Please find below a list of **sample** commitments. This is not an exhaustive list.¹

Examples of Commitments:

- Commit to developing, adopting and implementing National Action Plan/Gender Strategy on UN SCRs 1325 and 1820 using a participatory, transparent process that involves the highest level of political leadership, all relevant government agencies, and civil society;
- Commit to ensuring that at least 50% of the names submitted to the UN, and/or other multilateral organizations, for the election or nomination of persons to positions of special representatives or special envoys, or other high-level positions relating to peace mediation, peace negotiation, or peace keeping, are women; *[Ref: OP 2/1325; OP 12/1820; OP 16/1888; OP 1/1889]*
- Commit to introducing policies to increase the proportion of women in national police and military forces to at least 20 % by 2015; *[Ref: OP 5/1325; OP 12/1889]*
- Commit to adopting a zero tolerance policy to sexual abuse and exploitation by national security forces and develop and implement mechanisms for investigating and sanctioning perpetrators of sexual abuse and exploitation; *[Ref: OP 8, 9, 11 /1325; OP 3, 4, 7, 8/1820; OP 6, 7, 8a, 17/1888; OP 3, 10, 7, 20, 21/1889]*

- Commit to mandating that, by 2014, the proportion of police and military personnel deployed to peacekeeping missions will be equal to the proportion of women in national police and military forces; *[Ref: OP 3, 4, 5/1325; 19/1888; OP 4/1889]*
- Commit to measures to protect women's and girls' human rights are included in national security policy frameworks; *[Ref: OP 5, 6 /1325; OP 8, 9/1820; OP 11, 12/1888; OP 7, 8/1889]*

- Commit to ensuring that Terms of Reference for mediation teams include implementation of consultative mechanisms for ensuring women's participation; [Ref: OP 2, 8, 16 /1325; OP 12/1820; OP 16, 17/1888; OP 1/1889]
- Commit to establishing sexual violence desks within police forces and equipping them with specialized investigation equipment, such as rape kits, that enable them to gather forensic evidence associated with sexual violence; [Ref: OP 6,7,8,9,10/11/1325; OP 1,2,3,4,6/1820; OP 1,2,3,6,7,8a,17,19,20,24/1888; OP 2,4,10/1889]

 - parliamentary candidates
 - in parliaments
